#### IN THE BREAK ROOM – 6 Questions for Jon Johnson

The FSA's annual Legislative trip to Tallahassee – and indeed all of your Society's legislative work – would not be successful without the continuous collaboration with our long-time colleagues and lobbying firm, Johnson & Blanton. Founder Jon Johnson took a moment away from the current session to answer a few questions for IN THE BREAKROOM.

**ITB**: Many people find politicians and the entire political process "dirty." How do you do what you do, and why should a practicing physician care?

Johnson: When we first opened our firm our mission was to "provide

integrity-based representation to our clients." Always be honest, never make it up on the fly and be courteous to everyone in the process, whether elected or non-elected. As government takes over more and more of our healthcare system and is the BIGGEST payor, physicians should take an even more aggressive and keen interest in the process.

# **ITB**: How as the Florida legislature changed in character over the years J&B has been involved?

**Johnson**: The single biggest change is that legislators do not honor their word to the degree they used to. So taking your spoken word seriously and with weight has diminished. Be clear – this is not to all legislators; there still exist some very honorable elected officials.





#### ITB: Your proudest moment professionally?

**Johnson**: There are two that are pretty equal, and the one isn't just because FSA is asking these questions. But passing the AA licensure bill after fighting for three years was a big accomplishment. We also worked to secure a tax decrease for Oil Fields in Florida that helped save jobs and keep one large operation open in NW Florida.

# ITB: Your most challenging "throw in the towel" moment?

**Johnson**: In order to pass a bill that limited physician satellite offices and created tighter standards for supervision, I had to agree on the spot – with NO opportunity to check with clients – to allow PA's to sign charts without a co-signature. It caused a firestorm with a certain specialty, but I think ultimately they would say the trade off was worth it. But in the moment it was stressful.

## ITB: Most unusual place you've ever found yourself lobbying?

**Johnson**: You've heard it before, but I have lobbied a legislator in the bathroom...also on a rollercoaster at Universal Studios.

#### **ITB**: Most surprising or unexpected turn-around decisions? Johnson: Once I had a Senator – who has since passed away – flip his vote without warning on a contentious pharmacy bill. The bill passed by one vote, and we were trying to kill it. That one stings to this day.

#### From the Obstetric Anesthesia Committee

#### Happy Golden Anniversary, SOAP!



The Society for Obstetric Anesthesia and Perinatology (SOAP) will be hosting its 50<sup>th</sup> annual meeting on May 9-13<sup>th</sup>, 2018 at the Loews Miami Beach Hotel in Miami Beach, Florida. In honor of this 50<sup>th</sup> anniversary milestone, the US Surgeon General Dr. Jerome Adams, the first physician-anesthesiologist to serve in this position, will speak on the Opioid Epidemic. Given the ongoing opioid crisis nationally, special sessions will be dedicated to understanding and dealing with the opioid epidemic.

This year's meeting will begin with a day of pre-meeting workshops, including both hands-on skill development, such as the workshops on improving point-of-care ultrasound skills (e.g. transversus abdominis plane blockade, gastric ultrasound, transesophageal echocardiograms), as well as faculty development workshops for practicing anesthesiologists. In addition, a Spanish-language Latin American Symposium will include speakers from the US and Latin America, focusing on issues critical to care in Latin America.

The Annual Meeting will continue to feature current and groundbreaking research in obstetric anesthesia. Keynote lectures will include Gerard Ostheimer's "*What's New in Obstetric Anesthesia*" and "*What's New in Obstetric Medicine*." In addition, for the first time ever, there will be a one-day parallel clinical track with refresher course lectures for practicing clinicians on Saturday.

This year's meeting's theme is **Obstetric Anesthesia: Past, Present, and Future**. We would like to extend an invitation to all Florida anesthesiologists to participate in this exciting meeting. More information about the Annual Meeting will be available on the SOAP website (www.soap.org).
