FSA would also like to thank Drs. J. Knox Kerr and Rosemarie Garcia Getting for serving as delegates of their county medical societies.

Although quieter than the previous FMA Annual Meetings with all the educational sessions provided via the virtual format, this FMA Annual Meeting was overall a success! Dr. Chuck Chase, a dedicated leader within our FSA, was elected <u>FMA Treasurer</u> this past weekend. He will continue to be the voice of Anesthesiology within the FMA.

Another success was within the FMA HOD. While the HOD sessions discussed everything related to the practice of medicine, one resolution was particularly important for all the anesthesiologists--the Credentialing of Anesthesiologist Assistants (AA). With it, the FMA would support a change in statute that that Certified AA may not be denied clinical privileges at hospitals or ambulatory surgical centers as long as the supervising physician is a staff member in good standing. Also, no resolution with the potential of impeding the practice of anesthesiology were passed this year. The FSA apricates Drs. J. Knox Kerr and Brence Sell for dedicating their time as members of the FMA reference committees.

The representation of Anesthesiologists within FMA is absolutely crucial. It can allow all medical specialty physicians within the State of Florida to join force on blocking the scope of practice expansions by non-physicians, keeping our patients safe.
