### LETTER FROM THE PRESIDENT

Dear FSA Members,

Our Board of Directors and Legislative Affairs Committee have been very active for the past few weeks.

The Florida Legislature opened its 2022 Session on January 11th, 2022. Ever since then, our leaders have been visiting Tallahassee and continuing the work we began last year at the district offices of legislators.

We develop good relations with Legislators, this is the best way for them to understand who we are and what we do for patient safety. Our lobbyists, many of our members, and leaders began working on relations on the campaign trail, by being there and participating in the legislative process. Once an official has been elected, we are able to continue developing our relations, by offering to become their point person for any medical need, by giving them our cell phone number, and helping them navigate the healthcare system for themselves and their families.



Many of us, have also volunteered to be "Doctor of the Day" for the Legislative Chamber in Tallahassee. We serve as Physicians, as Primary care doctors, who either take care of a small problem or triage a major problem, directing the care to a hospital if needed. The reason why we can do this is that Anesthesiologists are Physicians first. This activity is appreciated by Legislators and their staff, as they visit the Legislative Clinic through the session.

Some of us have invited our Legislators to visit us at work, at our hospitals, or ASCs, so they can see how we lead the Anesthesia Care Team, as well as the Perioperative staff. This is the best way to experience what we do.

Our team has also invested in videos informing the citizens of Tallahassee on Physician-Led Anesthesiology. This is a common topic discussed during legislative visits. The Florida Society of Anesthesiologists lobbyists and the legislative affairs team continues to work on your behalf to maintain Physician-Led Anesthesiology in Florida.

## 2022 Florida Legislative Session Recap

Advocating for patient safety and our profession is a 366-day endeavor in 2022 for the Florida Society of Anesthesiologists Committee on Governmental Affairs. This comes into focus during the 60-day session of the Florida Legislature, which kicked off on January 11. The FSA has been well represented in Tallahassee, highlighted by our legislative days of January 24-25. Over 25 of your physician anesthesiologist colleagues sacrificed family and vacation time to press their elected officials to make sound policy decisions affecting how you practice perioperative medicine.

This year, the FSA will again be working to prevent independent anesthesia nurse practice by opposing HB 437: Collaborative Practice of Certified Registered Nurse Anesthetists and SB 986: Collaborative Practice in Health Care. The Senate bill is sponsored by the powerful Senate Health Care Policy Chairman, so we will be challenged for the 22nd year in a row to keep physicians as the undisputed leaders of the anesthesia care team.

The FSA will also be supporting clarity and transparency in clinical medical titles, HB 861 and SB 1192, Medical Specialty Designations. These bills address the deliberate blurring of the lines between physicians and nurses by the clinical use of confusing terms like "nurse anesthesiologist" and "nurse dermatologist". We are also following two pieces of legislation, HB 1101 and SB 1366, which will modernize the statute concerning Anesthesiologist Assistants and remove barriers to AA's entering the healthcare marketplace while still maintaining their supervision by anesthesiologists.

FSA leaders have spent time in the Capitol as the "Doctor of the Day", serving as the primary care physician for lawmakers, staff, and Hill personnel. This very public service demonstrates that all anesthesiologists are physicians first and specialists in anesthesia second, further highlighting our unique medical education, training, and skill set that differentiates us from our nursing teammates.

The FSA is only as strong as its membership allows it to be. Thanks to all of you who are virtually supporting our causes not only as FSA members and FSAPAC contributors, but also by allowing your practice colleagues the opportunity to do so in person on your behalf and those of our patients.

## 2022 Florida Legislative Session: A Fresh Perspective from Our FSA Member

After moving to St. Augustine from North Carolina in the summer of 2019, settling in, and then delaying life events for all the COVID-19 debacle, I was finally able to meet my Florida Society of Anesthesiologists (FSA) colleagues in person during my first visit to Tallahassee, representing the FSA for the 2022 Florida Legislative Session. Led by the FSA President, Dr. Leo Rodriguez, and attorney Jon Johnson with his great team, we met Monday night over dinner and prepared for visits Tuesday to our state legislators to discuss bills in committee this session. Dr. Jay Epstein, Chair of the FSA Legislative Affairs Committee, will summarize the meeting results and the bills elsewhere, but as a newcomer to the Florida anesthesiology scene, I would like to share my observations and insights from the trip.

Though I have been involved with state societies in past years (North Carolina and Georgia), the FSA feels different. "Like herding cats" is the phrase that often comes to mind when I think of trying to get physicians together. But this passionate group of doctors were well organized and worked together for clear goals for the visit. I and several other newcomers were heartily welcomed, and intentionally included in discussions and targeted visits to legislators. We were a group of thirty FSA members, diverse (though 86% male), from all over the state, academicians, private practice,



corporate employed, and per diem docs like me. We missed work and time with family to gather and devote effort to patient safety in Florida. Simply being with others who feel strongly enough to make that sacrifice was inspiring. Individual discussions, as well as group meetings, help spread ideas and enthusiasm among professionals – we have been missing this personal growth for several years now.

The demoralization of physician anesthesiologists is at an all-time high, my own included. Reimbursement is continually eroded, by insurers and the government. Documentation gets more onerous by the day. Corporate employers control our practice pattern. COVID-19 – well, we all know how that has affected the whole healthcare system, eroding doctor-patient relationships and trust, pay cuts for many of us during the darkest parts, despite personal risk and unchanged workload. Many nurse anesthetists, it seems, will never stop their attempts to evade physician supervision, despite almost comically less education and training than physician anesthesiologists. The flat out lying by the nursing lobby is unrestrained. My local representative from House District 17, Rep. Cyndi Stevenson, related being visited several weeks ago by several FANA (Florida Association of Nurse Anesthesiology to confuse the public) members. She asked them did they ever feel they needed a physician's help? "No, never," was their answer!

Too many physicians suffer from "learned helplessness," having lost the motivation to resist the forces against good practice. The FSA leaders and others maintain the fight for good patient care and common sense in anesthesia practice. Being with this strong group reinvigorated my determination to stop this nonsense, every year if we must. New issues with insurance and regulation arise every year, so the need to consistently visit and educate is clear. The attack on physician-led care has spread to all other medical specialties as well, and anesthesiologists help lead the battle against that "scope creep," with our experience. Several FSA members are also involved in the Florida Medical Society, in pursuit of that goal.

Our legislators and aides were welcoming, though their time for each constituent is brief. They were receptive to the message of patient safety, and to facts refuting the lies brought by the FANA. I enjoyed seeing the buzzing Senate and House office buildings. That money drives the whole machine is disappointing, but no surprise. But our representatives seem eager to hear from thoughtful physicians. I will return in February to serve as Doctor of the Day for the Senate, open to any physician sponsored by her or his senator or representative. The FSA should be proud our physician anesthesiologists are the most strongly represented specialty serving in that volunteer role this year, I believe. Those who have already served have found it a fun and interesting day to interact with staff and representatives, answer medical questions and discuss policy, as well as help take care of medical problems arising that day.

If you want to keep patient care in anesthesiology moving forward, get personally involved with the FSA! I am so glad I did.




#### Florida Society of Anesthesiologists Vigilant in Tallahassee


