Assistant Treasurer (Executive Committee)	1 year	2022-2023	The Assistant Treasurer assists the Treasurer on all duties of the Treasurer and keeps current in the duties of that office. The Assistant Treasurer will assume the position if Treasurer is not able to complete his/her term. The Assistant Treasurer learns about the financial and budgeting process of the Society under the Treasurer's guidance, and provides continuity of financial knowledge and leadership for the good of the Society. Term is one (1) year, at which point the Asst. Treasurer assumes the role of Treasurer and, over the course of the next 5 years, barring any unforeseen circumstances, should graduate through the officer ranks to become Society President.
District Director 1 North	3 years	2022-2025	There are three (3) District Directors in each of Florida's five districts. Each director must be a voting member of the Society and shall practice in his or her elective district. District Directors are key participants in the FSA's membership recruitment and renewal efforts. They are voting members of the FSA Board of Directors. Term is three (3) years with no term limit.

Florida Director to ASA	3 years	2022-2025	Each ASA component society elects a Director and Alternate Director. The Florida director serves on the FSA Board of Directors, submits an annual report to the ASA House of Delegates, reports the actions of the ASA Board of Directors to the members of the FSA, and performs other duties as designated by the component society. All Directors and Alternate Directors shall have been active members of their component society and an active member of the ASA for at least two years prior to their election. Florida's ASA Director also serves on the FSA's Executive Committee as a non-voting member. These positions are typically held by members with board member experience.

ASA Delegate 1 North	3 years	2022-2025	ASA Delegates must be voting members of the Society; they attend the ASA Annual Meeting and whenever possible counsel with the officers and directors on all matters pending in the House of Delegates of the ASA in the interest of making certain any action is in accordance with the desires of the society. They are voting members of the FSA Board of Directors. Term is three (3) years with no term limit. For those delegates associated with a certain district, the individuals must be a voting member of the Society and shall practice in his or her elective district.
