Message From the President

Greetings from Tallahassee!

In June we held our first Annual Meeting since the start of the CoVid-19 pandemic. It was great to see the large turnout of friends and colleagues who came for a long weekend of scientific sessions, political updates, educational workshops, wellness guidance, and furtherance of professional development. Our Annual Meeting program chairs, Luis Rodriguez, M.D. and Steven Porter, M.D. led the Program Committee in creating an informative, diverse, and stimulating event!

We are aware, however, that some of our colleagues who wanted to attend the meeting were unable because we did not have a large enough block of rooms reserved at the Breakers. We apologize to those who were unable to get a room at the Breakers. We made the reservations with the Breakers a year in advance of the meeting (while the pandemic was surging). We made our usual number of room reservations. Unfortunately, we had too few to accommodate everyone who wished to attend. We are currently in negotiations with the Breakers to increase our room allocation for next year.

On another note, it has become necessary to increase FSA dues next year. While our expenses have increased, we have not increased dues in more than ten years. After careful analysis and deliberation, our Executive Committee and Board of Directors have concluded that we need to increase dues. While we are currently in a financially sound position, prudence requires an increase. The dues for Active members will rise to \$495/year. To assist new members, we will follow the example set by the ASA and initiate a plan for new first-time members at a total cost of \$500 for the first 3 years.

Thank you for your membership in the FSA, your commitment to excellence, and your dedication to our patients and our profession.


FSA Solidarity in Diversity – Article by Sarah G. Bodin MD FASA



The Florida Society of Anesthesiologists (FSA) members amassed in Palm Beach in June for our 2022 FSA Annual Meeting, for the first time since the COVID-19 pandemic started, and for my first FSA meeting. I was struck by the beauty and glamour of the Breakers resort, and by the palpable thrum of diversity as a growing current in the FSA. As I write it is still June, the end of Pride Month, and my rainbow flag picture is still on my Facebook profile in support of my Lesbian, Gay, Bisexual, Transgender and Queer (LGBTQ+) friends, family, and colleagues. But "diversity" in anesthesiology requires much more than symbolism and social media posts.


Have you had surgery? Did you know your anesthesia care team? Most of us probably can hand pick colleagues that we trust to care for us and our loved ones. I did for my only general anesthetic, but on moving here to Florida and having my first colonoscopy at an outpatient endoscopy center, with an unknown CRNA and endoscopist, I held my breath and prayed that my good health and good airway would get me through unscathed. Imagine being unable to choose, as well as very unaware of what to expect. Imagine putting your life in the hands of someone who looks and acts nothing like you. How might you feel? If your caregiver looks like the group with which you identify, you likely will feel more secure. Yes, this is a generalization. But genuinely think about it. So many Floridians cannot have this arrangement, with the underrepresentation of minorities and women in anesthesiology. Raising a gay teen in north Florida, a very conservative area, has made me acutely aware of the sometimes oppressive and hostile atmosphere for those who are "different."

At dinner Saturday night, I was one of only two American-born Caucasians (myself and Dr. Beverly Philip, immediate past President of the American Society of Anesthesiologist, who grew up in an immigrant family). Seven others had family ties with China, Columbia, Cuba, India, Taiwan, and Venezuela. Our dinner conversation included tales of life stories so different from my own, all of which strengthened the profession of the individuals. Though we cannot expect representation of women and minorities in the medicine in Florida to approximate that of the population any day soon, awareness of where we are enlightens. Data from the Florida Department of Health on gender and ethnic demographics from 2021 are included below.

Thank you, Porter, for this public allyship. It is critical to keeping the momentum going. I felt the rise of diversity as a concept among the group, as a throughout newcomer, the meeting.

Our environment in medicine and anesthesiology is an ever-changing minefield that constantly strives for balance between patient-centered care, regulation, payment disparities, educational disparities, and corporate financial pressures. It may be increasingly difficult to get young talents into medicine and anesthesiology. Media and public confusion and pressure confound our realities every day. We MUST have each other's backs and raise each other up. It is required that ALL of us are involved in the active promotion of all valuable individuals. Diversity is rolling in the FSA – let's keep it moving and make it thrive!

Report on the 2022 Annual Meeting of the Florida Medical Association

Gorilla or Goat?



Is the Florida Medical Association the 800 lb. Gorilla advocating for medical issues in the Florida Legislature or the Scape Goat for social issues raised by members? That question was put to the test in Orlando at the FMA Annual Meeting in a hair-raising session of the House of Delegates (HOD), August 5-7, 2022. Social issues, such as abortion, open carry of guns and gender dysphoria, were on display. These resolutions were put forth by everyone from national organizations to individual members and medical students. In the weeks leading up to the meeting, a news organization used

leaked information to intimate a rift forming between the FMA and the Governor's office on these politically charged social issues. The truth, however, is that a resolution is only FMA Policy when it is voted on at the House of Delegates and passed.

Credit should be given to individual leaders in the FMA who chose to emphasize with impassioned speeches that we should not go down the road of the AMA on social issues, divisive to membership. Better avenues exist for advocacy through specialty organizations both in and outside of medicine. In addressing the House of Delegates, incoming FMA President Joshua Lenchus, clearly outlined our reasons to keep the focus of the FMA on helping physicians practice medicine, (which happens to be our vision statement), and not on social issues where consensus cannot be obtained. After much debate, the path forward for the FMA became clear and resolutions passed concentrated on the practice of medicine.

Interesting resolutions successfully navigating the HOD included home birth safety, tort reform, requiring a real physician at "Emergency" facilities, preventing elder abuse and assistance with spurious online ratings of physician practices.

Anesthesiology related issues of fighting the independent practice of nurse anesthetists and reserving the term 'anesthesiologist' for residency trained PHYSICIANS, remain at the top of the FMA Legislative Agenda. If you don't have time to be involved in the FSA and FMA, consider becoming a member of the FMA and FMA PAC as this is extraordinarily helpful to our profession. The FMA PAC is not partisan, it supports candidates on both sides of the aisle who are pro-medicine. Being a part of a much larger organization, like the FMA, gives us the backing of that 800 lb. gorilla.

STANDING COMMITTEES OF THE FSA

Communications Committee, chaired by Drs. Sher-Lu Pai & Zachary Deutch

This committee's duties encompass all matters relating to the improvement of the practice of Anesthesiology in the eyes of organized medicine and the public at large.
